## 3. Report from the National Office

CAPE President Emmanuelle Tremblay spoke about the current environment including the state of bargaining. Issues covered included: the drive by the government to dissuade employees from participating in the politics of the country; the need to reduce members' siege mentality; and, her priorities to share the Union's messages with members, encourage members to stay informed about the Union and participate in events including rallies.

### 4. Report from the local executive

addresses. He took this action with the objective to avoid using the employer's email system for communications with members. He requested that members update their personal information with the national office by providing their personal email addresses and cell phone numbers to facilitate possible mobilization and electronic voting.

He reported on the changes in the local's executive during the last year. Namely, Donovan Vernon replaced

Richard Ryczanowski as Secretary, and the appointment of Cindy loo as a Director.

John Szabo and Kerry Rhoades were asked to represent the local the Occupational Health and Safety Committee at 235 Queen. The local also gained representation on the HR Subcommittee of the National Labour Management Consultation Committee. John Szabo and our IRO will sit as our representatives. He presented lana Savard, a new steward who was appointed, for approval in accordance with the CAPE Constitution. Her appointment was so approved.
