**Motion:** It was moved by P. Rosen, seconded by A. Picotte, that the summary be approved, as amended.

In Favour = 3, Opposed = 0, Abstention = 1. **Motion carried**.

#### 2 a) Clause 6.11 tabled from August 20, 2008 meeting

In cases of ambiguity, interpret this Constitution by a simple majority of votes cast by the NEC, and/or refer the matter to legal counsel by a simple majority of votes.

**Motion:** It was moved by P. Rosen, seconded by A. Picotte, to accept clause 6.11

L. Perrin proposed a friendly amendment to add "and/or refer the matter to the Constitution and By-Laws Committee" at the end of the clause.

Friendly amendment was not accepted by the mover or seconder of the motion.

- P. Rosen requested a recorded vote.
- C. Lakaski = In favour, P. Rosen = Opposed, L. Perrin = Abstention,
- A. Picotte = Abstention, C. Therrien = Opposed

In favour = 1, Oppose = 2, Abstention = 2. **Motion defeated.**
