1. Memoriam of Trong Nguyen:

Action: J. Aggrey agreed to draft wording for Clause 11 of the Constitution in regards to "Removal of members on Sub-Committees" for the next meeting.

3. Matters Arising:

Wordsmithing

It was agreed that the Constitution and By-Laws require a complete review in order to flag any errors and further additions that may be needed.

Political Neutrality

It was moved by P. Rosen, seconded by J. Aggrey, **that** Clause 11.3 of the CAPE Constitution be amended by deleting from it the words `except for the Elections Committee`.

11.3 The President shall be an ex-officio member of all sub-committees, except for the Elections Committee.

And

That Clause 11.3 of the CAPE Constitution be further amended by adding the following new provision immediately after it:

11.3.1 No member of the National Executive Committee shall be a member of the Elections Committee.

It was moved by R. Oslund, seconded by D. Brackely, that the first paragraph and the word "and" be deleted. **Carried.**

A. Picotte proposed a friendly amendment to add the word "sitting" after the first word. Amendment was accepted.

The Main motion carried as amended reads:

`11.3.1 No sitting member of the National Executive Committee shall be a member of the Elections Committee.`.

4. Prescribed Procedures for the Creation of Sub Committees and Appointments:

Action: J. Aggrey will draft a By-Law for the next meeting.

5. Direction subsequent to the NEC Retreat with respect to C & B Committee:

Action: To be discussed at the next meeting after the NEC Retreat.

Recommendations from 2004 Election Committee:

Action: J. Aggrey agreed to re- draft By-Law 3.9 in regards the power of decision making to the sub-committee hearing an appeal.

Draft clause of Article 14.2

Action: M. Monaghan will draft some wording and bring forward at the next meeting.
