N. Giannakoulis added 3e – Motions from Wayne 3f – Collective Bargaining Expenses 3g – MBM Planning

1a. <u>Approval of Agenda</u>

1c. <u>Financial Statements for March 2017 including Statement of</u> <u>Financial Position</u>

S. Maguire asked why the Defense Fund has round numbers and does not include the interest.

S. Wensink indicated that the interest is in the short term investments and will be transferred to the Defense Fund at the end of the Fiscal Year.

3a. Follow up of F.C. recommendations

N. Giannakoulis indicated that a few changes were made prior to the budget being approved at the NEC meeting. Those changes were: removal of \$400,000 from the Defense Fund for 2018/19 and the Contingency Fund and Professional Fees were reduced by \$50,000 each in 2018/19.

3b. NEC – Financial Decisions

C. Vezina indicated that from dealing with large complaints like this, the amounts usually do not go down much.
