The NEC referred the discussion of the Defense Fund to the Finance Committee.

### C) Defense Fund

A. Trau proposed that the Finance Committee prepare a document and present it to the NEC on November 30, 2018 in order to receive their support. Once supported by the NEC, have it posted on the website for a discussion item at the CAPE AGM on December 4, 2018. After discussion, have a vote in late spring on dissolving the Defense Fund.

- G. Phillips indicated that CAPE should not eliminate the Defense Fund, but possibly change the investment strategy and not continue to make contributions to it. If any funds are used from the Defense Fund, replenish those funds and advise the membership on what the funds are being spent on.
- A. Trau asked if we would replace the Defense Fund with the Contingency Fund.
- N. Giannakoulis indicated that the NEC would have to amend the Terms of Reference for the Defense Fund.
- A. Trau would like to have the ToR amended in order to have a different strategy for investing.
- G. Phillips proposed possibly adding a cap of \$2,000,000 for the Defense Fund and the remainder go to the unrestricted reserves or possibly combining the Defense Fund and
