Our union must also be well managed. CAPE employees and representatives must be respected and well treated. Union dues and funds must be well spent. Unnecessary expenditures and subcontracts must be scrutinized, minimized and better managed. Conflicts of interest must be recognized and not tolerated.

If these issues and values are dear to you and represent your beliefs in what our union should be, vote for me and I will do everything I can to bring about these changes.

A vote for me means:

1. Low and stable union dues

- Greater scrutiny on how our union funds are spent
- Zero to minimal dues increase
- Flat and stable union dues
- All union dues increases must be well justified and ratified by the membership

2. A return to simple on-line voting

- All voting to be managed by union staff
- Voter registration must be simplified and inclusive
- Support for a constitutional amendment for automatic dismissal of anyone found guilty of vote tampering or irregularities of any kind

3. A return to common sense and simplicity

- Support a constitutional amendment for a two-term limit for the President
- No overtime pay or time off in lieu of for the President; executive pay for executive hours
- Wholesome review of the President's pay and benefits
- Protect the association from becoming radicalized

4. Promote our association as a professional organization

- Focus on members' rights and issues that directly impact our members
- Promote our members as professional public servants
- Respect for our employer, the Canadian tax payer
- Maintain only strategic alliances and no to joining the Canadian Labour Congress and similar organizations
